Cansas City

Carpenters build new KC training center

... and foot the bill themselves.

In October, more than 300 carpenters, contractors and dignitaries helped cut the ribbon on the union's state-of-the-art Kansas City Carpenters' Training Facility.

The \$8.2 million dollar project (designed by architectural firm Hollis + Miller and built by general contractor JE Dunn) houses 65,000 square feet of classroom and shop space, plus meeting rooms and offices for the council's Kansas City staff.

"Not one dime of government subsidy or public money went into this construction," Executive Secretary Treasurer Al Bond said. "This is a commitment and investment that we have made for our members and for the community, educating the best trained carpenters in the construction industry."

Funding came from the council's training trust fund and a grant from the United Brotherhood of Carpenters and Joiners of America.

Previously, the union was sharing a training facility in North Kansas City with other trades, while staff worked out of a smaller, separate location. "This gives us a lot easier access," Training Coordinator Bob Hale said. "It seems like everybody can get here quicker and, since this is our building, we can do with it what we want. We also have about 50 percent more shop space and more up to date classrooms."

Located across from Kauffman Stadium, the site had been the campus of Vatterott College. Extensive remodeling created room for the union's business office, health and welfare specialists, training staff and meeting space. It will serve about 5,000 active and retired members in the Kansas City area.

The Carpenters Regional Council staffs 12 training schools in Missouri, Kansas and southern Illinois.

Securing the Future

Study ranks Carpenters pension plan among the best

M

ultiemployer retirement plans are collectively bargained plans involving a labor union and two or more of its employers (contractors).

More than 10 million Americans are covered under nearly 2,000 of these plans.

At a time when economic turmoil and investment losses have crippled many pensions, the Carpenters Regional Council is bucking the trend and reporting impressive growth.


During a 10-year period beginning in 2003, the average fund saw yearly returns of just 5.9%. However, the Carpenters' plan, thanks to expert guidance and shrewd investing, performed better than most at 7.17%.

Fiscal year 2014 ended with an 8.1% return, while 2013 saw a whopping 14.3%.

A recent study by Horizon Actuarial Services, which included 803 construction industry plans, puts the Carpenters' Pension Trust Fund of St. Louis in the top 10 for investment performance.

In these volatile economic times, effectively managing the assets of our \$2.2 billion pension plan can be tricky. The trustees of our fund, under the guidance of Brian Goding, a financial consultant with Marquette Associates, deserve praise for their wise investment strategy.

"Nothing we do at the Regional Council is more important than guaranteeing the health and security of our members," Al Bond, executive secretary-treasurer

said. "I want everyone in our union to go home at night knowing that their investment is protected and that a first-rate retirement will be there when the time comes."

Special recognition goes to the 16 trustees of our fund and to Controller Juli Laramie and Assistant Controller Dave Bauer. Their vigilant oversight means that what we have worked so hard to gain is paying off for the future.

BIGGER. BETTER. STRONGER.

We grow our organization to make our lives and the lives of our members better. We all understand that manhours mean jobs for our members and manhours are what make our health and pension plans better.

There are three basic things that need to happen for us to grow our organization. We need to sign contractors, recruit new members and then our contractors need to be successful on bid day and win work.

So, what kind of growth did we experience in 2015 in Kansas City?

We signed 33 contractors to 47 area contracts. We signed large general contractors like McCarthy, Kadean and SM Wilson that have never had contracts in the Kansas City area before. We signed many sub-contractors, large and small, including Midwest Tilt-up which we'll talk about more in a little bit. For every segment of our trade - wood framing, interior systems, scaffolding, concrete, millwright and floorlayer - we added new contractors.

We were also very successful in recruiting new members. In 2015, 641 members joined in the Kansas City area. Of those 641, an even 600 are still with us. Out of the 600 still with us, 273 are on permits waiting to join a local, and 327 were initiated into our locals. Of our 327 new initiates that have joined a local, 125 are journeyman and 202 are apprentices. Nearly half the journeymen and nearly 90% of the apprentices are brand new to our organization.

As good as we've been at signing contractors and recruiting new members it doesn't helps us unless we win work. It's been said over and over that our best member retention program is a job.

One great example of what we've been able to accomplish is tilt-up work. We made a concerted effort to increase our market share when it comes to tilt-up work. Previously, 95% of all the tilt-up work done in Kansas City had been done by non-union contractors like Lithko, Summit, and Bed Rock Construction, which means we were sitting at about a 5% market share. To change that, we went to contractors like Fenix Construction, Concrete Strategies, and VeeJay Cement from St. Louis and convinced them to chase tilt-up work in Kansas City. We also signed a local Kansas City contractor Midwest Tilt-up. With Al Bond's help and some strategic use of market recovery, I'm glad to report that we are well over 50% market share in tilt-up work in the Kansas City area today.

There are other examples we can point to of huge wins for our contractors and members over the last year. Joe Hudson reported at our last council meeting on the 200,000 manhours we'll see on JE Dunn's Two Light Tower project, and putting ourselves in good position for Three Light Tower and Four Light Tower, which will be another 350,000 to 400,000 manhours in the next few years.

We have also been working to build strong relationships with developers in the Kansas City area. One area developer has worked on more than two dozen projects with us in the last couple of years and because of our financial resources and strong relationship, 100% of the carpenter work has been performed by our members. In 2016, that same developer will do more than \$100 million in construction and 100% of that carpenter work will be with our members.

All of these great things are only possible because at the end of the day we represent the hardest working men and women in the construction industry who consistently produce high quality work with a positive, let's-get-the-job-done-right and on-time attitude.

It's taken a lot of hard work by our agents here in Kansas City with help from Al Bond and strategic use of our market recovery, but by working together we are growing our organization.

My call to action to you today is to spread the word on our jobsites about the positive things we're accomplishing together. Urge our members to actively help our recruitment and political efforts. Inspire them to continually keep our productivity high and our can-do attitudes strong. And when we do, we'll make 2016 an even more successful year for all of us!

It takes a village to make some dreams come true.





Thanks to a helping hand from the Carpenters one lucky St. Louis family enjoyed the holiday season in their first home.

Just in time for Thanksgiving, Kenya W. and her two teenage sons moved into the house in the city's Bevo Mill neighborhood, which was built on an accelerated scheduled and completed in just 10 days. "My goal was to get a home someday, so I've been working and saving and trying to get to the point of getting my own house," she said.

Habitat for Humanity St. Louis, in partnership with KMOV-TV, organized the Home 4 the Holidays build, but getting it done and move-in ready in under two weeks required a lot of help. "We reached out to the Carpenters because who better to help us build a house in 10 days," KMOV General Manager Mike Murphy said. "You guys did a phenomenal job and were really generous with your time. We can't thank you enough."

A common misconception is that Habitat for Humanity builds homes and gives them away for free.

In addition to putting money toward their new house, owners also put in many hours of "sweat equity" during construction. Kenya said the time and labor spent on the job makes her new home even more special. "You learn a lot about what goes into building a house," she said. "To meet and work alongside all the people building it just means so much."

A dozen carpenter volunteers, mainly from the Belleville, Illinois training center, worked on the project. "We could not do what we do without our volunteers," Kimberly McKinney, CEO of Habitat for Humanity St. Louis said. "While we certainly need dollars behind our projects to buy the land and materials, we also have to have the volunteer labor. Skilled professionals like the Carpenters are crucial."

The modest four-bedroom house sits in a working-class neighborhood on the city's south side. You won't find the walk-in closets, stone fireplace or master bathroom popular in much of today's new construction.

But for Kenya and her family it's truly a dream home.

GROOMED FOR SUCCESS

Union Mentors Coach Newbies

Grow or die.

In today's business world, where increased competition and doing more with less are the new norm, attracting talent and keeping that talent motivated is a challenge every organization struggles with.

Understanding the need to recruit and retain the best people - and to change perceptions of union membership - Local 32 in St. Charles County is rewriting the playbook on new member initiation.

"Old school carpenters are stuck in their ways and hard to change," Wes Nettles, the local's vice president said. "We need to find the guys who have the passion and drive to make a difference."



An aggressive mentoring program launched in Local 32 targets newcomers for one-on-one attention, with the goal of getting them interested and involved in union activities at the outset.

The first task: enticing them to attend the local's monthly meetings.

"If I can reach them and keep them coming for 12 months I've pretty much got them hooked," Nettles said.

Mentoring is nothing new but it is on the rise in the American workforce. Seventy percent of Fortune 500 companies now report some type of mentoring program for new employees. To keep valued recruits from jumping ship to the competition they promote these programs as a company perk.

At the world's most profitable company, Apple Inc., co-founder Steve Wozniak credits early mentors for making the tech giant a success. The people who taught him and friend Steve Jobs how to build a successful company were invaluable to the pair of inexperienced young men with big ideas but little knowledge of business fundamentals.

"If you see a good mentor, you want to be a mentor when it's your turn," Wozniak has been quoted as saying.

The payoff for good mentoring programs is well documented. Rookies who have been coached by energetic leaders tend to stick around longer, feel a stronger connection to the organization and have a more positive work attitude.

That rings true for one of Local 32's newest members, Marshal Eversole, a 33-year-old from St. Peters. "Had I come to my first union meeting and nobody bothered to introduce themselves or talk to me, that probably would have been my last meeting," he said. "If you walk in and you're new to that place and people don't say anything to you, you're more likely to turn around and leave."

The local's leadership believes that something as simple as striking up a conversation can change attitudes and get carpenters more enthused about the union. *"If other locals initiate this I think it would keep new members coming back and keep them more involved...instead of just coming to their swearing in and then you never see them again ." -Thomas Duke*

New faces in the crowd are given a tutorial covering the basics, like creating an account on the carpdc.org website, where to pay union dues and how to get signed up on the out-of-work list.

Many of the recruits faithfully show up the monthly meetings, where attendance prizes are handed out as incentives to keep coming. After three consecutive meetings new members are eligible for a drawing to win jackets, shirts, coolers and gift cards. They also learn that coming to meetings is a good way to network and hear about job opportunities.

"I need to keep coming and keep my ear to the ground, that way if work gets slow I have a list of people I can call who I've met at the meetings," said William Bell. "Keeping those relationships open keeps me working."

Experts say the benefit of mentoring works both ways. Not only do newbies get experience and wisdom from seasoned veterans, but the mentors themselves feel more engaged and have a better understanding of the younger generation that will one day take over.

Encouraged by the results, the Regional Council is forming a committee to develop a how-to manual for all locals to follow when setting up their own mentoring strategy; making sure the best ideas are assembled and carried out consistently in all locals.

Union membership has changed across the country. Fifty years ago nearly a third of all workers belonged to one. In those booming days few union leaders had to concern themselves with recruitment programs or making their locals friendly and welcoming to outsiders.

Labor unions no longer have that luxury. Surviving into the decades ahead will mean cultivating new blood and preparing them for the demands of the job.

"The older generation wants to retire, they've done their fair share," Anthony Benskin, who joined Local 32 last year, said. "Now we've got to get in there and start taking the union down new roads. It's up to us to take leadership roles and make sure we have a safe place for our future."

2016 also represents an important milestone as we celebrate 50 years of the Home Building Industry Advancement Fund (HBIAF), which was created by the HBA in 1966 as a separate, not-for-profit corporation.

As background, HBIAF was created as a means of equitably funding both the training of carpenters for the region and as a way to generate funds to better the housing industry. The Nelson-Mulligan Training School in Affton is not only state of the art, it serves as a national example of industry collaboration and thousands of home owners have benefited greatly.

The current HBA representation on the oversight of the school consists of Bob Behlman (Behlman Builders) and Kevin Deptula (Builder's Bloc). They serve both on the Carpenters Joint Trust Fund (CJTF) Board which oversees ownership considerations of the school and as the official HBA appointees on the Carpenters Joint Apprenticeship Committee (CJAC) to oversee the school curriculum. Craig McPartlin (Con-Tech Carpentry) and HBA Executive Vice President, Bob Schenk, serve as alternates on CJAC.

Over the coming year as the 82nd HBA president, I intend to be a very active president – focusing on membership, along with greater public visibility and an expanded roster of meetings with key elected and civic officials. Why is this important?

As we continue recovering from the economy and see single and multi-family building permits continue to climb – there are plentiful opportunities to strengthen our industry. We must grow our membership and



continue to focus on our mission of keeping housing affordable and within reach for everyone in the St. Louis metropolitan area. Yet, with all of the challenges we face locally, there are two national issues I think equally worthy of our attention.

First, we must constantly remind the nation how important housing is to the strength of our local AND national economies. With a presidential election in roughly 10 months, it's vital that we remain highly visible and engaged with those candidates who support our industry.

Second, the U.S. homeownership rate fell to 63.4 percent in the second quarter of 2015, according to the U.S. Census. That is down from 63.7 percent in the first quarter and from 64.7 percent in the same quarter of 2014. It marks the lowest homeownership rate since 1967.

Finally, let me share with you some very positive observations from a recent Urban Land Institute conference:

76% of St. Louis survey respondents indicated prospects were good when asked to characterize the expected profitability of real estate in 2016.

When asked to rate development prospects, St. Louis survey respondents indicated infill and urban housing as excellent.

84% of St. Louis respondents indicated affordable/ workplace housing as 'important.' The national average is 77%

92% of St. Louis survey respondents considered infrastructure funding/development as an issue of importance.

I hope you and your family had a wonderful holiday season and that the new year is off to a good start.

Looking Ahead to 2016

Missouri's building contractors report lowered expectations for the construction industry's 2016 economic outlook in a recent AGC of Missouri Contractor Confidence (CCI) Index, looking six, 12 and 18-24 months ahead. The AGC of Missouri's CCI Index was conducted online in mid-December with member contractors and compares data collected six months ago.

Contractors in the Building Division report lowered expectations for 2016 – dropping their predictions to 63.39 points (down by 5.66) for six months, 61.61 points (down by 6.25) for 12 months, and 58.93 points (down by 4.76) for 18-24 months. Results of the CCI Index survey, based on 100 points, in the same category and conducted from July 15-July 30, were: 69.06 pts. (six months); 67.86 pts. (12 months); and 63.69 pts. (18-24 months).


Contractors in the AGC of Missouri's Heavy Highway/Infrastructure Division report a drop in their short-term confidence (42.5 points; down 9.58 from 52.08 points six months ago.) However, the same contractors show improved optimism when looking six months and 18-24 months ahead. The six-month outlook rose to 52.5 points (up 15 from 37.5 points) while the 18-24 month outlook moved up to 45 points (up 13.58 from 31.42 points) reported six months ago.

This most recent survey confirms what we have been hearing from our members across the state. While other parts of the country have seen a full recovery in the building industry, Missouri has been lagging in its recovery. Our state is falling behind in jobs and growth. Many of our members have been forced to find out-of-state projects to fill their pipelines.

Although the Highway/Infrastructure Division's longer-term confidence levels are up from six months ago, they still hover around (and below) 50 points and reflect tepid economic conditions. Many of our member contractors simply do not see the light at the end of the tunnel. Stop-gap measures in Washington, D.C. to temporarily fund transportation and summer seasonal work are most likely responsible for the uptick in the 12-month and 18-24 month confidence levels. There is no question that the lack of a permanent solution for federal transportation funding and Missouri's continuing lack of adequate funding for MoDOT continue to weigh on our state's economic conditions.

The survey was developed by the AGC of Missouri and was distributed online as well as in-person at recent meetings to member contractors. The CCI index is released quarterly and is designed to be an additional tool to help business, government and institutional leaders plan for the future.


